THAT'S 56 ANIMALS ARRIVING THROUGH OUR DOORS DAILY SEEKING SAFETY, LOVE, AND HOPE. AS THE ONLY OPEN-ACCESS SHELTER SERVING THE STATE OF DELAWARE, SEVERAL COUNTIES IN PENNSYLVANIA, AND THE WASHINGTON D.C., AREA OVER HALF OF THE ANIMALS RECEIVED WERE LOST PETS HOPING TO FIND THEIR WAY HOME OR INTO THE LOVING ARMS OF A NEW FOREVER HOME. THE REMAINING PETS WERE ANIMALS WHO MAY HAVE BEEN AT RISK OF EUTHANASIA AT OTHER OVERCROWDED SHELTERS BOTH LOCALLY AND FROM SURROUNDING AREAS, PETS IN NEED OF REHOMING DUE TO NO FAULT OF THEIR OWN. FREE-ROAMING COMMUNITY CATS, AND VICTIMS OF ANIMAL CRUELTY OR NEGLECT. OF THE 20,596 ANIMALS ARRIVING THROUGH OUR DOORS IN 2024, 3,261 OF THOSE ANIMALS WERE WELCOMED THROUGH THE HUMANE SOCIETY OF HARRISBURG AREA WHO THE BRANDYWINE VALLEY SPCA MERGED WITH AT THE END OF 2024.

ANIMAL HEALTH CENTERS - THE BVSPCA BELIEVES STRONGLY IN PROVIDING ACCESSIBLE AND AFFORDABLE VETERINARY CARE FOR ALL PET OWNERS REGARDLESS OF INCOME LEVEL OR SOCIAL STATUS. BY PROVIDING THIS ACCESSIBLE CARE, PET OWNERS IN THE SERVICE AREAS OF THE BRANDYWINE VALLEY SPCA'S 6 ANIMAL HEALTH CENTERS ARE LESS LIKELY TO SURRENDER THEIR PETS OR NEGLECT TO PROVIDE NECESSARY VETERINARY CARE DUE TO FINANCIAL CONSTRAINTS. IN 2024, THE BRANDYWINE VALLEY SPCA PERFORMED 31,027 SPAY/NEUTER SURGERIES, PROVIDED 3,044 FREE PET VACCINATIONS, AND PERFORMED 24,612 PET EXAMS THROUGH ANIMAL HEALTH CENTERS. OF THOSE 31,027 SPAY/NEUTER SURGERIES PERFORMED, 4,685 WERE PROVIDED THROUGH THE HUMANE SOCIETY OF HARRISBURG AREA WHICH THE BRANDYWINE VALLEY SPCA MERGED WITH AT THE END OF 2024. THEY ARE ALSO THE PROVIDERS OF 638 OF THE FREE PET VACCINATIONS PROVIDED AND 4,876 OF THE PET EXAMS PERFORMED.
